### 2024

#### 1. DURATION

The specification for a period of 12 (twelve) months.

#### 2. SCOPE OF WORK

##### Broader Services description

- 2.1. The Service Provider undertakes to convey the relevant Goods to the relevant Consignees by collecting the Goods from the collection address assigned by the CCMA and delivering same to the designed Delivery Address on or before the relevant Delivery Date.

##### Service Scope

- 2.2. The service provider shall, for the duration of this SLA, provide the following courier services to the CCMA:

2.2.1. Express Courier Service, in respect of which parcels are delivered same day or overnight;

2.2.2. Economy Courier Services, in respect of which all parcels within 72 hours;

2.2.3. Premium Services, where in urgent cases, Goods are delivered after hours, on weekends and during public holidays;

2.2.4. Track and trace services in respect of Goods collected or delivered pursuant to this Agreement, which shall include:

- 2.2.4.1. Setting up appropriate systems which will allow for remote tracking of shipment on a continuous basis;
- 2.2.4.2. Generating and providing tracking numbers for Goods collected for the purpose of delivery;
- 2.2.4.3. Providing confirmation of collection or delivery of the goods, as the case may be.

2.2.5. Submission of delivery notes and service feedback after every delivery.

### **Service expectations**

2.3. It is expected that the Service Provider will ensure that:

- 2.3.1. Goods are to be collected and delivered timeously;
- 2.3.2. Goods reach the delivery address(s) sealed and in a state that they were received, without any form of tempering or damage;
- 2.3.3. Constant updates of delivery status are sent to the CCMA via SMS or email;
- 2.3.4. Order instructions are adhered to without any deviation.

### **Service requisition and delivery**

- 2.4. It is generally agreed that Services will be requested at short notice from time to time, as and when required by the CCMA, during the contract period.
- 2.5. In the event that the CCMA requires any of the Services, the CCMA shall provide the Service Provider with a written order for service.
- 2.6. The Service Provider shall immediately confirm receipt of an order.
- 2.7. Goods must be collected immediately after the receipt of an official order.
- 2.8. As soon as the Goods have been collected, the Service Provider shall furnish the CCMA with a tracking number and method.
- 2.9. Once in possession of the Goods, the Service Provider shall cause same to be delivered to the delivery address within the agreed period. Delivery of Goods must be made in accordance with the instructions appearing on the CCMA's order.
- 2.10. Deliveries not complying with the order forms will be returned to the Service Provider at the Service Provider's expense.
- 2.11. All deliveries or dispatches must be accompanied by a delivery note stating the order number against which the delivery has been effected.

### **Minimum Order Quantities**

2.12. The minimum acceptable order quantity in respect of all services, excluding economy service, shall be 1kg per order.

2.13. The minimum acceptable order quantity for economy services shall be 10kg per order.

#### **Service Availability**

2.14. For the duration of this SLA, all Services procured herein shall be available 24 hours per day and 365 days per year, including weekends and public holidays.

#### **Service limitations / exclusions.**

2.15. The Service provider shall only provide courier services:

2.15.1. in and around the Gauteng province; and

2.15.2. across all South African provinces i.e. from one province to another.

2.16. Save for Gauteng province, the Service Provider shall not be commissioned to render courier services within the other South African Provinces or internationally i.e. from one town to another within the same province.

2.17. This SLA does not include the following services:

2.17.1. Courier services for human/animal body parts;

2.17.2. Courier services for goods weighing more than 1 ton.

2.18. Notwithstanding clause 7.17.2 of the above, should the CCMA require courier services in respect of such Goods, then the provision of such services will be on a basis of a written quotation.

### **3. SERVICE PROVIDER RESPONSIBILITIES**

3.1. The Services Provider shall ensure that:

3.1.1. Services provided meet the service expectations of the CCMA;

3.1.2. Services are provided timeously, diligently and in accordance with the requirements of the CCMA and the provisions of this SLA;

3.1.3. In the provision of services, compliance with all statutory or regulatory provisions, in force from time to time, and at all time is observed;

3.1.4. Where Goods requiring collection by the Consignee from the Service Provider or Delivery address, have not been collected within a reasonable time and in any event within 10 (ten) Business Days after the Service Provider has notified the Consignee in writing that the Goods are available for collection at the relevant Delivery Address or Collection Address (as the case may be) then, the Service Provider shall notify the Sender of the Consignee's failure to collect the Goods and the whereabouts of the Goods;

3.1.5. Provide timeous notification to the CCMA where it is unable to make a collection of deliver due to *vis major*;

- 3.1.6. Ensure that transit and storage conditions applicable to the relevant products are adhered to;
- 3.1.7. Ensure that all parcels are wrapped and made up on the premises or collection address;
- 3.1.8. Where the CCMA is only able to provide the estimated weight and price of the Goods, the Service Provider shall provide the CCMA with the exact weight and price within 7 (seven) days after the Goods have been collected from the relevant premises or collection address;
- 3.1.9. Furnish the CCMA with the service feedback, which shall include the following information:
  - 3.1.9.1. The price;
  - 3.1.9.2. The weight;
  - 3.1.9.3. The destination;
  - 3.1.9.4. Collection Address;
  - 3.1.9.5. P.O.D (proof of delivery).
  - 3.1.9.6. Electronic Waybill
- 3.1.10. Ensure that it adheres strictly to the delivery lead times.
- 3.1.11. Ensure that all deliveries or dispatches are accompanied by a delivery note stating the official order number against which the delivery has been effected.
- 3.1.12. Ensure that all sensitive parcels are packed in tamper evident seal bags.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for B-BBEE with the tender, will be interpreted to mean that preference points for B-BBEE are not claimed.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
