A letter of good standing is only valid for 2 months upon request. Please ensure that the expiry date falls on or after the bid closing date. if the expiry date is before the bid closing date, the bid will be disqualified.

The CCMA is a public entity and some of our users come with guns in the building. The CCMA has made provision for safe keeping of firearms which must be managed

by competent security guards. The service provider must ensure that all officers that will be deployed onsite are fully conversant with the regulations and have the relevant competencies to handle guns. It is therefore prudent for the service provider to not only have the competencies but must comply with the relevant laws and regulations of the firearms Act and must have the necessary firearm licenses.
