### 2 SCOPE OF WORK: -ODA Relocation

- 2.1 Backup your data:** Ensure that recent and reliable backup of the databases is in place to safeguard against any potential issues during the move.
- 2.2 Proper shutdown:** Gracefully shut down the ODA using the appropriate management interface (Oracle Appliance Manager) to avoid data corruption.
- 2.3 Disconnect cables:** Unplug all power cords, network cables, and any attached storage devices.
- 2.4 Physical transport:** Carefully move the appliance to the new location, ensuring proper handling to avoid damage and ensure that there is Goods in Transit (GIT) cover for the equipment, which is valued at One million, six hundred thousand rand only (R1 600 000.00) of which proof of cover should be provided to the CCMA before the hardware is relocated from current premises, and in addition to provide security escort through South African Police Service or their own Transport Protection Services to ensure that the goods are safely transported.

## 2.5 Set up new environment:

- i. Place the ODA in the designated rack and connect power cords.
- ii. Connect network cables and any necessary storage devices.
- iii. Ensure proper clearance and compliance with the rack specifications.

## 2.6 Power on and configuration:

- iii. . Check database status and restart if needed.

  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.
