1. BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

1.1 Background of service or goods required

The Commission for Conciliation, Mediation and Arbitration (CCMA) is an independent and autonomous organization that was established by the Labour Relations Act of 1995 (LRA) to deliver dispute prevention and resolution services to the people of South Africa. The core mandate of the CCMA, as one of the organizations charged with implementing the LRA, is derived from the purpose of the LRA which, amongst others, is to advance economic development, social justice, labour peace and the democratization of the workplace.

Fifteen (15) CCMA Officials to receive Virtual Training on Effective Presentation Skills. The training will be held on 11-12 September 2025.

The appointed service provider must note the duration of the training required and the request to pitch the training session at the appropriate level considering the type of attendees who will be in attendance. The training/workshop must be delivered under SAQA Unit Standard: 8647.

1.2 Overview on RFQ

It is vitally important that the service provider produces a highly effective, practical, and innovative training which will enable the participants to demonstrate their understanding and application of the requisite methodology correctly.

- Develop awareness of how effective non-verbal messages are communicated.
- Improve meetings through effective communication skills.
- Gather, structure, and organise a formal report using mind-mapping effectively.
- Design and use appropriate visual aids to support your presentation.
- Deliver and evaluate their presentation by reviewing a video for a more professional impact.

RFQ special conditions

- 1.2.1 The successful service provider should have a proven track record of successful delivery of this service in other organizations. Proof needs to be delivered in the form of written confirmation and comments from other organizations.
- 1.2.2 The training/workshop must be held virtually and must be conducive to all in attendance.
- 1.2.3 A high level of expertise is expected of all personnel dealing with this project. Proof of expertise, experience and Post graduate qualifications need to be submitted in the form of short resumes.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS
