1. ISANDULELA SOMQONDISI wakwa-CCMA

IKhomishani Yokubuyisana, Ukulamula kanye Nokwahlulela (i-CCMA), ngokuhambisana noMthetho Wokukhuthazwa Kokufinyelela Olwazini wesi-2 wezi-2000, njengoba uchitshiyelwe¹ (i-PAIA), ilungiselele le Manuwali ye-PAIA ukuze kube lula ilungelo lomphakathi lokufinyelela olwazini oluphethwe yi-CCMA. Le manuwali kufanele ifundwe kanye noMhlahlandlela wokuthi isetshenziswa kanjani i-PAIA, njengoba ishicilelwe yi-Isilawuli soLwazi. Imininingwane yokuxhumana ye- Isilawuli soLwazi inikezwe ngezansi ukuze kubhekwe kuyo kanye nolunye usizo.

Isigaba se-32 solMthethosisekelo weRiphabkulikhi yaseNingizimu Afrika, 1996, sisungula ilungelo lawo wonke umuntu lokuthola ulwazi olugcinwe uMbuso kanye nezinhlango ezizimele lapho lolo lwazi ludingeka khona ukuze kusetshenziswe noma kuvikelwe noma yimaphi amalungelo. I-PAIA yenza leli lungelo lisebenze futhi ikhuthaza isiko lokubeka izinto obala, ukuziphendulela kanye nokuphatha okuhle kuzo zombili izinhlaka zikahulumeni nezizimele. Ngokwenza kanjalo, isekela ukuzibophezelu komthethosisekelo wezwe kuntando yeningi evulekile nebambe iqhaza.

Le ncwadi ibeka izinhlobo nezigaba zamarekhodi agcinwe yi-CCMA futhi ibeka izinqubo nezimfuneko zokucela ukufinyelela kuleyo mininingwane. Le manuwali ihloselwe ukusiza noma yimuphi umuntu, kuhlanganisa nabangebona abezizwe, ukuthi baqonde ukuthi bangalisebenzia kanjani ilungelo labo lokuthola ulwazi ngendlela esemthethweni nenolwazi.

I-CCMA iyavuma ukuthi ilungelo lokuthola ulwazi aliphelele futhi linganqunyelwa ngaphansi kwezimo ezithile. Le mikhawulo² iqashelwa kukho kokubili i-PAIA kanye Nomthetho Wokuvikelwa Kolwazi Lomuntu Siqu 4 wezi-2013 (POPIA) futhi isebeenza ukulinganisa ilungelo lokufinyelela namanye amalungelo nezintshisakalo, njengokuvikelwa kobumfihlo bomuntu siku, ubumfihlo, amalungelo angokomthetho, kanye nezinjongo ezisemthethweni ezhlobene nokusebenza kwezinhlango.

Ngokuhambisana ne-PAIA, i-CCMA ingase idingeke ukuthi inikeze ukufinyelela kumarekhodi ngisho nalapho kunezizathu zokwenqaba, uma ukudalulwa kwerekhodi kuzoveza ubufakazi bokwephulwa okukhulu, noma ukwehluleka ukuhambisana nomthetho, kanye nentshiselela yomphakathi ekudalulweni kwerekhodi ngokusobala idlula umonakalo ohlongozwe kunoma yiziphi izizathu zokwenqaba ukuthola amarekhodi.

- 3.9. bazi ukuthi i-CCMA ihlele yini ukudlulisa noma ukucubungula Ulwazi Lomuntu Siqu ngaphandle kweRiphabulikhi yaseNingizimu Afrika kanye nabamukeli noma izigaba zabamukeli okungase kuhlinzekwe kubo Ulwazi Lomuntu Siqu; futhi
- 3.10. bazi ukuthi i-CCMA inazo yini izinyathelo zokuphepha ezifanele zokuqinisekisa ubumfihlo, ubuqotho kanye nokutholakala kolwazi lomuntu siqu okumele lusetshenzwe.

4. UKUSUNGULWA KWEKHOMISHINI YEKUXHULISANA, UKUXOXA KANYE NE-KULAMULA

4.1. Umthetho Wokusungula

- 4.1.1. I-CCMA iwuwlaka olusemthethweni olusungulwe ngokwesigaba 112 soMthetho Wezobudlelwano Babasebenzi, 1995 (uMthetho No. 66 ka-1995), njengoba uchitshiyelwe (LRA).
- 4.1.2. I-CCMA ibuswa Isigungu Esilawulayo esisungulwe ngokwesigaba 116 se-LRA. Isigungu Esilawulayo siqukethe usihlalo namanye amalungu⁴ ayisishiyagalolunye, ngalinye liqokwe yi-NEDLAC futhi liqokwe uNgqongqoshe Wezokuqashwa Nezabasebenzi ukuthi libambe isikhundla iminyaka emithathu, kanye noMqondisi we-CCMA (oyilungu lesigungu esilawulayo kuphela ngenxa yokuthi uqokwe njengomqondisi).
- 4.1.3. Ngokwesigaba 116 se-LRA, isigungu esilawulayo siyisigungu esiphezulu esenza inqubomgomoye-CCMA.

- 1998 (“i- EEA” njengoba uchitshiyelwe Nombolo 55).
- 4.2.4. I-CCMA izimele ngaphansi koMbuso, noma yiliphi iqembu lezombusazwe, inyunya naya basebenzi, umqashi, izinhlangano⁵ zabaqashi, umfelandawonye wezinyunyana noma umfelandawonye wezinhlangano zabaqashi. Inegunya kuzo zonke izifundazwe eziyisishiyagalolunye zeRiphabulikhi yaseNingizimu Afrika.


